



Best Poster Award

The IUFRO Honors and Awards Committee invites applications from eligible candidates for the Best Poster Awards. The purpose of these awards is to encourage public dissemination of high quality research and to recognize distinguished poster presentations by younger scientists during the IUFRO World Congress.

One Best Poster Award will be made for each of the nine IUFRO Divisions. These awards, in the form of a certificate, will be presented during the IUFRO World Congress at the Division meetings on the evening of Friday, October 10th. Special mention of the award winners will be made during the closing ceremony and the names of award winners will be published in IUFRO News.

Eligibility

The award is open to any poster presenter under 45 years of age at the time of the IUFRO World Congress. The awardee's parent organization must be a Member Organization of IUFRO, or the awardee must be an Individual Member of IUFRO. No member of the IUFRO Enlarged Board is eligible for the award while holding such office.

Criteria

Awards will be made for outstanding poster presentations at the IUFRO World Congress. The following factors will be taken into account:

Quality of Research Design:

- Clarity in stating the problem (hypothesis)
- Identification of important variables and factors
- Appropriateness of research approach
- Recognition of limitations in the data
- Degree to which the data support the conclusion
- Uniqueness or originality of the research topic.

Poster Design:

- Effective use of graphs and/or tables in presenting data
- Logical organization and neatness of poster
- Accuracy of spelling and grammar

Selection

The <u>full text</u> of the poster (no illustrations) must be submitted to the Chair of the IUFRO Honours and Awards Committee, Dr. Shirong Liu, at <u>liusr@caf.ac.cn</u> with a copy to Renate Prüller at <u>prueller@iufro.org</u> by **31 August 2014**. Posters will be judged by the IUFRO Divisional Coordinators and/or their Deputies.
