



Graduate Research Assistantship Position Announcement

The Department of Forestry in the College of Forest Resources and the Forest and Wildlife Research Center at Mississippi State University are seeking applicants for a funded M.S. assistantship. The successful candidate will work under the direction of Dr. Shaun Tanger and Dr. Eric McConnell in the area of forest logistics, which includes topics related to timber production, timber procurement, forest operations, and economic development.

The anticipated research will seek to better understand wood supply logistics in the southern United States, with a focus on Mississippi. The study topic will focus on bridge infrastructure in Mississippi vital to the forestry sector and the student will have regular interaction the Mississippi Forestry Commission. The candidate will be expected to communicate his/her research results in writing through peer-reviewed journals, conference proceedings, and/or Extension fact sheets and bulletins. Presentations at regional, national, and international meetings will also be required. Thus, applicants must be independent and passionate about furthering their education in forestry and or a closely related field.

The assistantship is available beginning in August 2021 for the fall semester or January 2022 for the spring semester. The 2- year position includes a stipend (\$18,000 annually), tuition waiver, and insurance.

Required qualifications:

- A bachelor's degree in forestry, natural resources, forest and/or bioproducts, or a related field, such as agricultural economics or agricultural engineering
- Ability to meet all admissions requirements to the Department of Forestry M.S. program
- Demonstrated excellence in English (written and oral) communication skills
- Valid driver's license

Preferred qualifications:

- A background or strong interest in seeking solutions to economic, management, and policy issues affecting natural resources
- Interest or experience in using Excel or Google sheets, GIS, and Optimization tools to solve research problems
- Experience conducting undergraduate research
