# Small-scale Rural Forest Use and Management: Global Policies vs. Local Knowledge

The IUFRO International Symposium on "Small-scale Rural Forest Use and Management: Global Policies versus Local Knowledge", held in Gérardmer, France, from June 23 to 27, 2008, explored the important role of local knowledge in managing small-scale rural forests and the impacts or implications of broader 'global' policies on small-scale rural forestry.

### **Local Knowledge**

In many regions of the world, forest activities are carried out by the rural population on collective lands and by individual farmers on agroforestry or farm forestry plots. These types of forest activities play an important role in sustaining rural communities. The management of the related wooded areas is usually based on traditional local knowledge which is particularly adapted to the ecological and socio-economic conditions of the area. The common feature of all these different practices is that they are carried out at a small-scale level, with adaptive management.

#### **Global Policies**

The management of forests is, however, also influenced by broader regional, national and international policies, which are almost always developed remote from the local areas in which they are to be implemented. These 'global' policies often present an abstract and even sometimes idealistic vision of the role of the forests in rural development, and may propose means and mechanisms which are not fitting to the real issues faced by rural communities in managing their forests. In addition, despite a rich heritage of traditional or local forest knowledge in many regions, forest administrators, managers and policy makers are often not aware of this knowledge base and do not consider it in their decisions.

During the symposium week, more than 100 specialists from almost 30 countries in the world exchanged their experiences and visions on this complex issue. The papers presented generated a long and rich discussion which gives a clear illustration of the challenges ahead for scientists, managers and policy makers alike.



As a satellite meeting, a Pre-conference Research Training Workshop devoted to « Systems Analysis as Applied to Forest Policy and Management Issues », was organized in Nancy, France, from June 19 to 21, 2008, by AgroParisTech-ENGREF and the University of Queensland, with an additional concrete support from UNESCO and the Regional Government (Conseil Régional) of Lorraine. This initiative provides a good example of the relevance of the science-policy interface on concrete topics such as the one addressed by the conference. It also shows the interest to hold inter-division meetings devoted to specific scientific topics, which can enhance multi-disciplinary approaches.

In order to support the discussion during the symposium, specific **Pre-Conference Proceedings** (Buttoud, G., Ed., AgroParisTech-ENGREF, Nancy, 280 p.), including the full papers discussed in plenary sessions, and summaries for the other ones, were made available to participants at the beginning of the meeting.

## **Eurodendro 2008 - The Long History of Wood Utilization**

EuroDendro, the conference of the European Working Group for Dendrochronology, took place from May 28 to June 1, 2008 at Hallstatt, a small village in Upper Austria. The conference was hosted by the Institute of Wood Science and Technology, the University of Natural Resources and Applied Life Sciences, Vienna, along with IUFRO Units 5.01.07 Tree Ring Analysis and 6.07.00 Forest and Woodland History. 175 persons from 36 countries registered for the conference, which included 34 oral presentations and 83 posters. There were four sessions: Forest and wood utilization; Dendroclimatology; Forest growth, dynamics and protection against mass movements; and Wood formation and wood anatomy.

Organizers Michael Grabner and Daniela Geihofer and their team chose Hallstatt for the site of the conference because the Institute of Wood Science and Technology has carried out intensive research at Hallstatt for the last ten years. The village and surrounding area are a world famous archeological site which has been on the UNESCO World Heritage List since 1997. There are mines dating from the Bronze Age as well as from the Early and Late Iron Age. Numerous interesting wooden pieces and structures have been discovered at the prehistoric salt mines.

EuroDendro 2008 also provided Ph.D. students an opportunity to present their work and afforded all the scientists an occasion to interact and to learn about the latest findings of their colleagues, especially on the topic of dendroarcheology. This was a very exciting and interesting conference and one that will be long remembered by all attendees.

## Forest Entomologists in South Africa

The conference, "Recent Advances in Forest Entomology" was held from 1-6 July, 2008, in Pretoria, South Africa. It was sponsored by IUFRO Unit 7.03.00, "Entomology" and hosted by the Forestry and Agricultural Biotechnology Institute (FABI) at the University of Pretoria, South Africa.

The conference was organized as a satellite meeting to the International Congress of Entomology that was held the following week in Durban. This was a hugely successful conference that facilitated scientific exchange among a remarkably international selection of delegates, representing 21 countries. In addition to scientific sessions, delegates had the opportunity to view some of the challenging problems facing entomologists in the African continent.

The conference was attended by 63 delegates representing 21 countries. Funding for local travel expenses of 5 young scientists from countries with developing economies was provided by the Korean Forest Research Institute. A total of 37 oral and 10 poster presentations were given, including three keynote presentations: "Forests and forestry in South Africa" by Jolanda Roux, "Recent advances in forest entomology: An international perspective" by Andrew Liebhold and "Forest entomology in South Africa" by Mike Wingfield.

This conference represented the continuation of a tradition in IUFRO Research Group 7.03.00 of holding a satellite

meeting in conjunction with the International Congress of Entomology which is held every four years. As in previous years, the meeting was a chance for forest entomologists to take a little extra time and meet on their own, network and build strong relationships with fellow scientists who share common interests, as well as become acquainted with local entomological problems.

This conference was particularly successful in meeting these goals, in part because of the unique geographical representation of delegates, particularly from countries in Latin America and Africa which typically are under-represented at IUFRO meetings. However, the other important ingredient to the success of this conference was the creativity and hard work of the sponsors from FABI. Their enthusiasm and dedication to science was infectious, resulting in a conference that delegates found to be one of the most stimulating and enjoyable of their careers.

Reports were presented on a variety of research topics. However a common theme among several presentations was the subject of novel associations between tree species and insect pest species, brought about either by invasions of exotic insect species or by host shifts by native insects onto exotic tree species. Later, during the field trip, attendees were able to observe and discuss these novel associations while visiting forest plantations.

# Norwegian MCPFE Secretariat starts work with new working program and new visual profile

## Climate, energy and water will be the focus areas of

Europe's forest co-operation and collaboration process, which Norway is going to chair for the next four years.



The Ministerial Conference

on the Protection of Forests in Europe (MCPFE) has been important for Europe, where forests now cover more than 40 percent of the land area. Europe's forests also represent 25 per cent of the world's forest resources and are increasing fast. Since the first conference took place in Strasbourg in 1990, the forest area has increased by 13 million hectares - about the area of Greece - and the forest volume by 360 million cubic metres. This corresponds to more than half a billion trees.

The new visual profile makes clear the great economic, environmental and social importance of forest collaboration on the national and international level. MCPFE applies to Europe, but at the same time its political work is connected to the global work of the United Nations for forestry and sustainable development.
