## **IUFRO** at the Global Landscapes Forum

On 16 and 17 November 2013, the first Global Landscapes Forum (GLF) was organized at the University of Warsaw, Poland, on the sidelines of the 19th Conference of the Parties (COP19) to the UN Framework Convention on Climate Change (UNFCCC).

In previous years there had been two separate events, the Forest Day and the Agriculture, Landscapes and Livelihoods Day. The combination of the two events aimed to establish a joint global platform to raise awareness on the importance of sustainable landscapes. The Global Landscapes Forum drew more than 1200 participants including policy makers, scientists, climate negotiators, civil society, media, etc.

Discussions focused on four major themes: investing in sustainable landscapes in forests and on farms; landscape policy and governance for forestry, agriculture and other land uses; synergies between adapting to and mitigating climate change in forest and agricultural landscapes; and landscapes for food security and nutrition.

## Discussion Forum

## Governance and legal frameworks for sustainable landscapes IUFRO, IDLO, CIFOR

There has been a global consensus since the Brundtland Report that environmental, social and economic challenges must be addressed equally to achieve sustainable development. We also have consensus that any policy response to sustainable development challenges must incorporate multi-level governance and cross-sectoral approaches. Despite this consensus and despite the many efforts to achieve sustainable development, there is ongoing frustration about the slow progress.

This slow progress is therefore not due to a lack of attention to goals and problems, but is instead owing to a lack of learning around policy instruments. We suggest that learning, which integrates knowledge about how policy pathways have succeeded - or failed



- to solve problems is a missing step: this is referred to as a policy learning architecture.

## **Discussion Forum**

## Linking gendered knowledge with genderresponsive action in the landscape: What works? WFO, FANRPAN, IUFRO, CIFOR

In a discussion forum on linking gendered knowledge with gender-responsive action in the landscape, it became clear that making the case for the potential of a landscapes approach to build climate change resilience depends in large part on showing the resilience of the women who are part of those landscapes. (...)

Seema Arora-Jonsson from the IUFRO Working Party on Gender Research in Forestry began the session by examining truisms concerning women and climate change. The most striking of these truisms are that women are the poorest of the poor and are more prone than men to die in natural disasters. However, data about local socioeconomic contexts is often lacking, and there is no conclusive evidence to support these truisms. Still, this begs the question: Are these inaccurate claims being used to portray women as helpless victims? Why is it necessary to cast them in this light at all?

## The International Conference on Wood Adhesives 2013

The International Conference on Wood Adhesives 2013 took place from 9-11 October 2013 in Toronto, Canada, and involved <u>IUFRO Division 5 Forest Products</u> and Research Group <u>5.04.00 Wood Processing</u>.

From adhesive suppliers to users of the downstream product, from industry to academia, government, or NGO, this conference provided an opportunity to interact with leaders in the field from around the world and hear about the latest developments. It is held every 4 years, this time with 226 attendees from 28 countries, and was organized by the US Forest Service, Forest Products Laboratory, the Forest Products Society, and the University of Toronto.

To encourage industry participation, the Wood-Based Composites Center (WBC), a U.S. National Science Foundation Industry/University Cooperative Research Center, was invited to hold their semi-annual Industry Advisory Board Meeting in conjunction with the Conference. Forty WBC industry professionals and faculty and seven WBC graduate students participated in both meetings. The WBC is a multi-university research center focused on conducting member-requested fundamental research for the wood composites industry while training future professionals. This model worked well for both groups and will be repeated for future conferences.

### **Key topics**

Several talks discussed how the **adhesives cured on a sheet** to make an easy specimen for testing can, in some cases, have properties very different from the same adhesive cured between two pieces of wood. The difference is that wood absorbs certain low molecular weight components from the adhesive before cure is complete. Data was presented which suggested this absorption phenomenon influenced bond properties in such diverse areas as physical morphology, extent of cure, thermal-mechanical stability, bond strength, and formaldehyde emissions, among others.

**New analytical methods** continue to allow researchers to ask questions that previously could not be addressed. New applications in nanoindentation, x-ray tomography, x-ray fluorescence, and modeling, for instance, are making new experimental approaches possible.

Strong interest continues in developing **bio-based alternatives to conventional products**. Multiple talks were driven by a desire to replace fossil fuel based materials with bio-based materials.

Plenary session speakers discussed the **outlook for wood adhesive needs** and requirements (consumer and regulatory) in North America and Europe. The keynote emphasized the power of transformational thinking to create enormous value to a company and its customers.

Winners of the Student Poster Competition included Jesse Paris, Oregon State University (first place), Matthew Schwarzkopf, Oregon State University (second place), and Ashley Hellenbrand, University of Maine (third place). All three students are supported by the Wood-Based Composites Center, WBC.

A peer reviewed conference proceedings will be electronically published in January by the Forest Products Society. Work has already begun in terms of choosing a venue for the next International Conference on Wood Adhesives in 2017, with Chris Hunt (<u>cghunt(at)fs.fed.us</u>) as point of contact.

He participated also in a satellite meeting of the "Asia-Pacific Forest Invasive Species Network" (http://apfisn.net/) which was well attended by forest health experts from the region. There he gave a presentation on ecological risk assessment, and highlighted some of the work that is being done in IUFRO.

## 18th International Nondestructive Testing and Evaluation of Wood Symposium 2013

The 18th International Nondestructive Testing and Evaluation of Wood Symposium was held on September 24–27, 2013, in Madison, Wisconsin, USA (http://www.forestprod.org/symposium2013/). The event was hosted by the USDA Forest Service's Forest Products Laboratory (FPL) and co-sponsored by IUFRO 5.02.01 Nondestructive Evaluation of Wood and Wood-Based Materials.

This symposium was a forum for those involved in nondestructive testing and evaluation (NDT/NDE) of wood and brought together many NDT/NDE users,

suppliers, international researchers, representatives from various government agencies, and other groups to share research results, products, and technology for evaluating a wide range of wood products, including standing trees, logs, lumber, and wood structures.

Networking among participants encouraged international collaborative efforts and fostered the implementation of NDT/NDE technologies around the world. 190 scientists from 21 countries attended this event. Over 150 technical presentations were

made in 12 technical sessions and one poster session. The technical content of the 18th Symposium has been captured in 800 pages of proceedings, which can be accessed from FPL's website: <a href="http://www.fpl.fs.fed.us/">http://www.fpl.fs.fed.us/</a>

The 18th Symposium was especially important because in addition to its strong technical content, it was a celebration of 50 years of this symposium series! The opening session, "From Strong Beginnings to an International Research Community," included keynote speakers from around the globe who presented the state-of-the-art in nondestructive testing and evaluation of wood.

A special publication, *Fifty Years of Nondestructive Testing* and *Evaluation of Wood Research - International Nondestructive Testing and Evaluation of Wood Symposium Series*, was produced by FPL (FPL General Technical Report 213) in commemoration of the 50<sup>th</sup> anniversary.
